The word translated as “sky” or “expanse” is the Hebrew word *raqia*, which literally means something spread out or hammered like a sheet of metal. Early Jewish commentators, like those who wrote the Book of Enoch and the Septuagint translators, viewed the firmament as **a solid structure**—a dome covering the flat Earth.

Genesis says this firmament was where God placed the **sun, moon, and stars** (Genesis 1:14–17), not millions of miles away in deep space. They move within the dome, above the Earth, lighting and marking time for us—not orbiting a rotating ball.

In a 1954 interview, Byrd mentioned that **Antarctica was larger than the United States**, and spoke cryptically of **a land beyond the South Pole** filled with resources and unexplored territory. Flat Earth

theorists suggest that Byrd may have discovered that Antarctica is not a continent, but a **barrier**, and that the powers of the world quickly moved to cover up this information.

Shortly after his expeditions, the **Antarctic Treaty** was signed in 1959 by over 50 nations, **prohibiting independent exploration** of the region. To this day, **no private citizen can legally explore Antarctica without government oversight**.

### 3. The Antarctic Treaty: Secrecy at the Edge

The **Antarctic Treaty System** is one of the most unusual and strict international agreements in history. It prohibits any military activity, mining, or unapproved exploration on the continent, and it restricts freedom of travel more than almost any other place on Earth.

Even high-altitude balloons, reaching heights of over **100,000 feet**, show the horizon flat and at eye level in unaltered, non-fisheye camera footage.
